There is a malacious attempt by the Samithi for this action and I request you to send notice to hear the parties and issue written order for contravening the provisions of act u/s 4[1]. since the last renewal by 31.7.2014.

I beg to the registrar that the pending complaints as well as the current one be sorted out at your end with due hearing and request you to stop the practice of calling AGM/ special General body meeting without discussing them in committee meetings against the provision of bye-laws of the society.

I request the Dy. Registrar, (ROSoc) to look into my complaints and call AGM with your order and your observers to sort out the issues of not obeying rules and regulations and contravening the provisions of Act. The entire list of members is also enclosed for your kind perusal.

Also please take action on the linked society Muthamizh Sangam Lucknow (I-68503).

Dear Secretary (VVS).

I would like to remind you that 90 days deadline for accounts statement/AGM is fast approaching and what is the stage of accounts statement of 2014-15 including TDS/interest accrual statement from bank on savings/FD deposits as of 31.3.2015

I also remind you that you had been convening AGM straight without committee meetings and there is no provision to call AGM without approval of committee or signed request by one third of members.

The Samithy under chairmanship of SGS is not adhering to this and you had been secretary since 2013.

Also renewal of registration is due

You have not put the agenda of discussing accounts since 2006 submitted for last year renewal of registration done under my signature You have not given me any opportunity to discuss in any committee even, when it was my baby until **2012**.

After wards it is present treasurer/Secyś baby. and in all these previous two years as well as hopefully just concluded 2014-15 are having Balance sheet problems even after due tallied receipt payments.

You had also pending termination of membership (of myself) show cause notice with due signature.

There is also writ petition No. MIS(s) 5913 of 2014 in High court with opposite parties as ROS, DyROS, secretary, president of Sri Ayyappa Sewa Samithi. You have never bothered to enquire what is the full content of WP and for due discussion in Samithi. Simply You caught hold of one word 'culprit' and had assumed it of SGS and he had shown your full strength on pouncing on me. It is the duty of president to identify the 'culprit, is it secy, treasurer or any other signatory or CA and so on.

Do you also want to follow Muthamizh Sangam wherein Secy had replied to my ROS complaints in personal capacity without convening AGM? and then on finally unable to bear my onslaught trying to silence me by saying I am not a member at all.
