SUB: Matter/complaint to be discussed in AGM before election

dear members,

This is not a comprehensive complaint (Which runs 185 pages), but only some questions.

**Who is to appoint Chartered accountant:**

Is there anything in history of Muthamizh sangam that committee had approved as CA and ratified by AGM. How come madras based CA had been appointed for the years 2010-11. 2011-12, 2012-13. Is CA supreme or Genral body supreme. Are u preparing statements for General body or just for other legal departments such as IT without passing it in AGM.

**How dare are u to declare NIL balance as of 1-4-2010.**

You have aquired **18000 sqft land** in Gomti Nagar (in which u can certainly construct auditorium with capacity 1000 seats) about four and half times the current one as on 16-3-2010 and on 1.4.2010(after 29 years of existence of the society) the Secretary had declared NIL balance hiding full pumpkin in a plate of rice. The secretary is the signatory to it and found way to IT department. Such a team is re-elected. Whom I can complain (only to God).

**Again a pumpkin of concealing Rs. 82 lacs to IT**

As of 31st March 2011, 5 pm closing balnce was Rs 87 thousand and as on 1st April 2011, 10AM you had declared Rs. 83 lacs as opening balance. That is by overnight You had gained Rs, 82 lacs and concealed the sale deed of real estate. I am not questioning the valuation (which comes under technical audit), I am simply questioning the simple audit. The president is of the opinion that I should not question the CA prepared statements. Is CA supreme than your general body. I have made complaints to ROS as well as informed IT with solid proof of signature of CA and secretary.

Yet it had gone on deaf ears. God is with you and it is raining in your forest.

**No agenda, no annual report, no audited balance sheet etc.**

You are conducting AGM since 2012 (before that there is no record of AGMs including the election of the team in 2010 with Acharya Shri SG Swaminathan as president) without proper agenda **no annual report, no audited balance sheet etc.**, in spite of bye-laws specifically mentioning three items on agenda. I had made umpteen complaints to ROS and on his inaction moved to High Court\* with my grievances. With the rejection of my petition by Hon'ble justice Masoodi, you can very well continue your AGM activities with this sort of no agenda no annual report no **audited** balance sheet and also not sending to **All** members. The glaring omission of not sending any communication including the AGM notice is to Shri R Ramani (IAS retd) who is still on record with ROS as continuing president since 2010-11 hiding another pumpkin of the election of president Shri SG Swaminathan. With respect to this decision of High court You have been given full legal license to continue your nefarious designs.

I had raised many including the proper procedure not adopted for taking in Mr Kesav Gurnani as patron. Everything is going on deaf ears.

As of April 2, 2015, the court put such a firm question on my lawyer that I presumed the court is asking such question in order to reject my petition, so this letter was drafted before the 2nd listing on April 7, 2015. On the second listing my advocate replied properly and Learned Standing Counsel prays for and is granted a week's time to seek instructions about the outcome of notice dated 26.09.2013 as contained in annexure no. 5 to the writ petition. Now the matter is in the court and the case **status** is neither admitted nor rejected and still **pending**.

Following persons had not attended a single committee meeting from 1-4-2010 to 5.4.2014 and be absolved of all the above charges: namely, 1. Shri K D N Sharma, 2. Dr V Rajamani, Dr. Vijay kumar and 4. Dr Damodaran.
