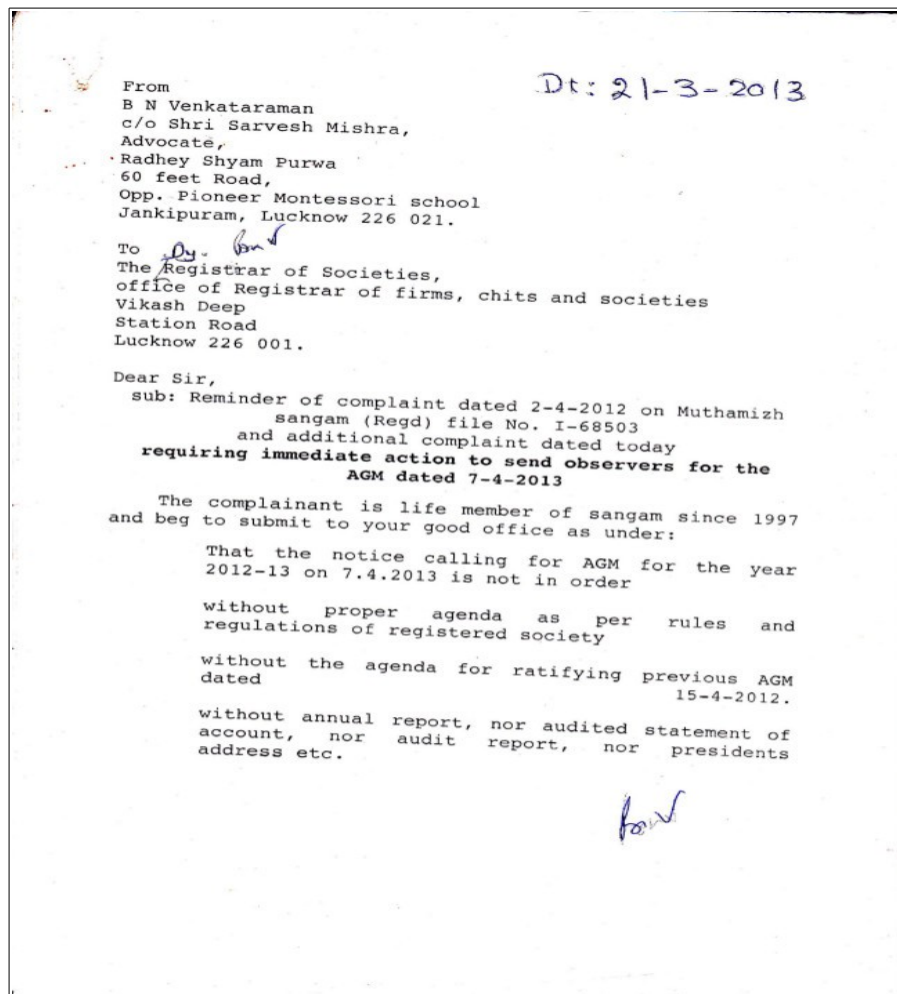

4. That, the Dy. Registrar called for hearing on 9.10.2013 also next hearing on 31.10.2013 with reply from the Secretary, Muthamizh

Sangam Lucknow, herein after called as the secretary vide letter No. 1869/I-68503/Lucknow dated 26.9.2013 of the Dy.Registrar.

5. That, in none of the replies submitted to the office of Dy.Registrar by the secretary, the sangam has not denied nor disputed the life membership of the deponent.
6. That, during the hearing on 9.10.2013 at the office of Dy.Registrar, the very first question put by the Dy.Registrar was that whether the deponent is a member or not and the office bearers and member of the sangam viz. The president, the secretary, treasurer, auditor and another member shri K R Subramaniam all iterated that the deponent is a life member and everybody said in the affirmative.

That, after the hearing on 31.10.2013 at the office of Dy.Registrar, the deponent and the secretary jointly agreed for a Chatered Accountant vide letter dated 12.11.2013 which is shown below with the scanned copy. This also proves that the deponent is a member and well associated with various events of the sangam.

**Re: Re-rejoinder of Shri B N Venkataraman dated 06-11-2013**







That it is a fact that the petitioner is confronting the Society, namely Muthamizh Sangam in its Annual General body meeting and


That in AGM dated 13th April 2014, Shri B N Venkataraman questioned the President/Secretary for not circulating proper Agenda.


